What makes a student eligible for Pupil Premium?

Children can be eligible for Pupil Premium for a variety of reasons including family circumstances, income, care status and previous care arrangements. The funding is provided to improve educational outcomes for disadvantaged pupils and help close attainment gaps.

Use of Pupil Premium Funding

Pupil Premium funding may be used for literacy and numeracy support, reading interventions, social and emotional development, educational resources, attendance support, behaviour support, staff training and targeted interventions that improve outcomes for disadvantaged pupils.

Pupils may benefit from:

- Additional support for literacy and numeracy
- 1:1 interventions for self-esteem and social skills
- Purchase of equipment and software
- Revision and homework guides
- Behaviour support
- Reading intervention sessions

Pupil Premium Funding History

- 2020/21: No Pupil Premium funding received.
- 2021/22: No Pupil Premium funding received.
- 2022/23: No Pupil Premium funding received.

- 2023/24: £25,000 received and allocated to IT resources and targeted interventions to develop functional IT skills.
- 2024/25: £24,000 received and allocated to school libraries, phonics training, P4C training and PDA Level 5 accredited staff training.
- 2025/26: £1,828 received and allocated to staff training. Remaining funding has been carried forward and will be combined with future allocations to support evidence-informed interventions, resources and targeted provision for disadvantaged pupils.

- Attendance and engagement support
- Educational resources and learning materials
- Therapeutic and pastoral interventions

5. Direct resources to accelerate progress and close attainment gaps.
6. Track and evaluate the impact of spending.
7. Ensure leaders maintain oversight of allocation and impact.
8. Ensure staff understand who is eligible and their responsibility for progress.
9. Ensure governors monitor effectiveness and outcomes.

Pupil Premium Plus

Pupil Premium Plus is allocated to local authorities to support looked-after and previously looked-after children. Funding is linked to Personal Education Plan targets and may be applied for by the school where appropriate.
